## **ELIGIBILITY APPLICATION: Confidential Disclosure Agreement**

**WHEREAS** the Applicant has provided the Neighborhood Housing Trust with certain personal information related to this Eligibility Application; and

**WHEREAS** the Neighborhood Housing Trust has requested submission of the information contained on the attached Eligibility Application, including certain information pertaining to the Applicant's qualification for bank financing.

**NOW THEREFORE,** in consideration for the mutual purposes of the Applicant and the Neighborhood Housing Trust, the parties agree as follows:

- 1. **Disclosure**. The Applicant agrees to disclose, and the Neighborhood Housing Trust agrees to receive, certain Confidential Information.
- 2. Confidentiality. Neighborhood Housing Trust agrees to use its best efforts to prevent and protect the Confidential Information, or any part thereof, from disclosure to any person other than those having a need for disclosure, including: the employees of Neighborhood Housing Trust, members of the Board of Directors of Neighborhood Housing Trust or any of the Board's committees or subcommittees, and certain consultants having a need for disclosure in connection with Neighborhood Housing Trust's authorized use of the Confidential Information.
- 3. **Limits to Confidential Information**. Neighborhood Housing Trust shall have no obligation with respect to such information where the information:
  - a) was known to Neighborhood Housing Trust prior to receiving any confidential information from Applicant;
  - b) has become publicly known through no wrongful act of Neighborhood Housing Trust;
  - c) was received by Neighborhood Housing Trust without breach of this Agreement from a third party without restriction as to use and disclosure of the information;
  - d) was ordered to be publicly released by the requirement of a government agency.
